Vendors can rent "space" to exhibit and sell their products within the designated area on a first come, first served basis by completing this form and submitting all pages before the deadline. Vendors will receive confirmation of their accepted application via e-mail or phone. No duplication of food or items will be allowed.

This is a family oriented Cruise-In. Crude. Vulgar or suggestive items will not be allowed. With my signature I understand that the Vendor Coordinator herein has the sole authority to designate which of the items or services will actually be allowed to sell or offer.

Tables and chairs are available for rental when reserved at 3 days before the event. 8' tables \$11 each, Chairs \$2 each. We will have them delivered and picked up after the show. Limited low draw 120V power is available on a first come first serve basis for \$2.

Assumption of Risk

The Concessionaire acknowledges that the operation of an activity at the Cruise-In involves a certain amount of personal risk from accidents, which could occur. Nevertheless, Concessionaire agrees to risk any such accidents or injuries on its own behalf and on behalf of officers, agents and/or employees and agrees to hold the City of Salem, the Pentastar Pride Car Club, their officers, agents or volunteers and Roberson Chrysler Jeep harmless.

Setup/Teardown

Vendors will be allowed to set up from 6:00 a.m. to 7:00 a.m. the day of the Cruise-In (vendors arriving after 7:00 am will not be allowed to set up and will forfeit their registration fee). Vendors will be responsible for properly disposing of all trash and debris from their Space during teardown. Teardown may begin at 3:30 p.m., but no support vehicles (pickups, cars, trucks) will be allowed to enter the area until all show vehicles have exited the area. Pentastar Pride Car Club reserves the right to charge a \$50 clean-up fee for all trash not properly disposed of. Trash receptacles will be available throughout the vending area.

Vendor Equipment

Vendors may furnish their own display tables, tents, or booths. Tables and chairs may be rented at the Cruise-In (see fee schedule). Vendors will be required to provide all equipment to be used in the preparation and serving of food and drink items, including refrigeration if necessary. All vendors and their equipment must comply with applicable local and state health, fire and public safety codes. Vendor must have a workable fire extinguisher on site if heating devices of any kind are to be used in the preparation of food items.

Banners, Signage, Sound & Video

Signs and/or banners pertaining to Vendor's concessions must be attached to the tent, display table, booth, vehicle or trailer and cannot project beyond its height. Sound emitting from the booth or vehicle must not compete with the show in any way.

Compliance with Laws

Concessionaire agrees to comply with all laws and regulations, which apply to the operation of his or her particular concession, including any Health Department Regulations concerning food as well as the regulations of any other public entities which govern the activities of the concession being operated. Vendors will be responsible for obtaining all local or state health permits and must provide proof of insurance. Electrical devices must be in compliance with the laws of the State Board of Electricity, and if not inspected prior to arriving at the show, be prepared to have them inspected with the vendor responsible for the cost of the inspection.

Indemnification

The Concessionaire agrees to protect, defend and hold Roberson Chrysler Jeep, the Pentastar Pride Car Club members and officers harmless from and against any liability of any kind arising out of concessionaire’s operation of a concession at the Pentastar Pride Car Show. This agreement extends to all injuries and damages to persons and/or property except that caused exclusively by the Committee, their officers, agents, employees or volunteers. This agreement extends to the agents and employees of the City and to its officers and officials. The Car Club makes no representation as to the number of potential attendees and assumes no liability for any financial loss due to Vendor’s operation at the Car Show. Vendor assumes all responsibility for 1) loss, personal injury and/or liability for any damage to its property or merchandise; and 2) any sickness or illness caused from the food and/or drink served from its concession. Vendor expressly agrees to indemnify, protect and hold harmless the Car Club, its officers, directors, principals, executive committee members, and Car Show sponsors from any liability whatsoever in connection with this event.

Hours of Operation: The Car Show will operate from 8:00 a.m. to 3:00 p.m.

Right to Terminate

Pentastar Pride retains the right to terminate this agreement provided to the Concessionaire. This agreement may be terminated in the event that the Cruise-In is canceled or the Concessionaire breaches any of the terms hereof. No liability shall result to Pentastar Pride, Roberson Chrysler Jeep as the result of any cancellation of the Cruise-In or termination of this concession agreement. This signed document represents the entire agreement between the Concessionaire and the Pentastar Pride Car Club with respect to operating of a concession at the Cruise-In. There are no oral promises or commitments to the terms of which are not included within the written terms hereof.
